Mark Smith reported that there isn't too much going on at the Interlocal right now and the monthly meeting is this week.

Kirby Honeycutt reported: set up a new server; 3 IDL setups-2 are set up; working on IPads; Two Trees will be here to finish mapping wiring; Siemans is working on the door lock project; and the security video server needs a new mother board.

Dr. Durborow reported: custodians are working on building maintenance; 3 kids, 1 from Chetopa and 2 from St. Paul, attended National FBLA and Kendra Spielbusch placed 7th.

Dr. Williams reported: need to recruit someone to appoint to the board; Gannon case will be heard by the Supreme Court on July 18 and Charity Qualls hasn't paid her penalty yet.

The KASB policy updates were discussed. A motion, "I make a motion to accept KASB policy updates for district policy as presented" was made by Craig Sanders and seconded by Rocky Billings. The motion passed, 6-0.

After some discussion, a motion, "I make a motion to accept the changes to the Student, Staff, and Coaches/Sponsors handbooks as well as the fundraising policy as presented" was made by Craig Sanders and seconded by Mark Smith. The motion passed, 6-0.

Mark Smith left the meeting at 7:37 PM.

After reviewing the quotes, a motion, "I make a motion to accept the bid in the amount of \$7920.74 from Derailed Commodity for flooring in the manicure facility" was made by Tammy Bushong and seconded by Mike McCracken. The motion passed, 5-0.

Mark Smith re-entered the meeting at 7:41 PM.

A motion, "I make a motion to deed all remaining land in the Hornet Addition, lots and undesignated, to the City of Chetopa" was made by Craig Sanders and seconded by Tammy Bushong. The motion passed, 6-0.

In other matters, Dr. Williams reported: still getting quotes on a health services contract; St. Paul sports complex project was granted a 90 day extension; and discussed the new resolutions for LOB and capital outlay. A motion, "I make a motion to adopt the resolution to expand the use of capital outlay to computer software; performance uniforms; housing and boarding pupils enrolled in an area vocational school operated under the board; architectural expenses; building sites; undertaking and maintenance of asbestos control projects; school buses; utility expenses; property and casualty insurance; and other fixed assets, and with respect to any redevelopment district established prior to July 1, 2017" was made by Mark Smith and seconded by Mike McCracken. The motion passed, 6-0. A motion, "I make a motion to adopt the resolution to increase Supplemental General Fund to 33%, the maximum allowed by law" was made by Mike McCracken and seconded by Tammy Bushong. The motion passed, 6-0.

An executive session was called for to protect the parties involved in matters related to negotiations to discuss the latest offer concerning teacher compensation, leave, contract days, evaluation, and fair dismissal [75-4319]. A motion, "I make a motion to go into executive session until 8:05 PM to discuss matters related to negotiations with the board, Dr. Williams, Dr. Durborow and Terri Ross" was made by Mike McCracken and seconded by Craig Sanders. The motion passed, 6-0.

The open meeting resumed at 8:05 PM. An executive session was called for to protect the parties involved for discussion of matters related to non-elected personnel in filling supplemental contracts and classified raises [75-4319]. A motion, "I make a motion to go into executive session until 8:15 PM to discuss matters related to non-elected personnel with the board, Dr. Williams and Dr. Durborow" was made by Craig Sanders and seconded by Rocky Billings. The motion passed, 6-0

The open meeting resumed at 8:15 PM. A motion, "I make a motion to approve Mike Ferraro, Chetopa senior class sponsor; Mark Haight, SPMS cross country coach; Jessica Schertz, CHS concessions manager; and Krystal Adams, CJHS concessions manager" was made by Craig Sanders and seconded by Tammy Bushong. The motion passed, 6-0. A motion was made by Tammy Bushong and seconded by Mike McCracken to give Terri Ross a 2% raise. The motion passed, 6-0.

A motion was made by Rocky Billings and seconded by Mike McCracken to adjourn. The motion passed, 6-0. The meeting adjourned at 8:20 P.M.
