

Unified School District No. 505, Labette County, State of Kansas

February 14, 2022

Roberta Carter, president, called the meeting to order at 7:00 PM with all members present, except Tyler Pike and Julia Nash. Others present: Craig Bagshaw, Superintendent; Jolene Paden, Chetopa K-12 administrator; Keaton McCracken, St. Paul K-12 administrator; Josh Brennon, District technology; and Terri Ross, clerk.

A motion, "I make a motion to approve the agenda as presented" was made by Seth Born and seconded by Kari Chambers. The motion passed, 5-0.

The consent agenda included the minutes of the January 10, 2022 meeting; bills; VISA bill; and January activity accounts. A motion, "I make a motion to approve the consent agenda as presented" was made by Seth Born and seconded by Brad Harris. The motion passed, 5-0.

Under SEK reports, Roberta Carter reported that SEK is starting to look at numbers to determine where staff is to be placed.

Under technology, Josh Brennon reported: had to replace 3 iPad chargers; possible grant to purchase IDL equipment; and Two Trees is working on a plan to upgrade the network.

Under principal reports, Mr. McCracken's reported: Fastbridge winter screening is done; HS girls basketball has only lost one game; HS boys basketball has had some tough matches; powerlifting meet on Saturday; HS scholar bowl was one question away from going to state; FBLA had 3 kids qualify for state; and still addressing issues of why students are leaving. Ms. Paden reported: JH/HS MTSS groups are starting; had a motor on a heating unit blow up; participating in the national ESEA conference virtually; working on CTE internship possibilities; Nikki Adams received a thousand dollar FFA grant for her SAE egg project business; Parsons Sun will be doing an article on the FFA program; FFA attended a job interview contest where Nikki Adams received 11<sup>th</sup> overall in the A team and Grace Lance received 9<sup>th</sup> overall for the B team; PSU career day is tomorrow and we will be taking brochures to promote our district; starting to hand out a Hornet pack for new babies in Chetopa; HS boys basketball is working hard and HS girls basketball has 2 injured players.

Under superintendent reports, Mr. Bagshaw reported: as of now, the snow days don't need to be made up; since we must replace one unit since it burnt up, he has approved to do 2 units so we get a better benefit for the crane use; would like to replace the boiler in the MS; 4 adults and 9 kids lifting weights at St. Paul; possible wellness check to see if it would lower the Blue Cross rates; have a long-term sub at Chetopa for Danica Strasser who is out on maternity leave; discussed the idea of all of the Labette County schools working as one voice to promote this area; still haven't received a solution for the St. Paul lunchroom floor that is still not fixed; and we must do a needs assessment for the district to determine the needs in the budget.
